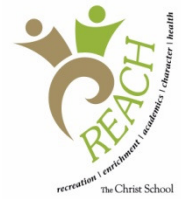




# The Christ School REACH Enrollment Contract



The Christ School's REACH program is for students who need care before or after school. Each child who participates in REACH must be enrolled for the full academic year. The REACH program follows the school calendar. After-school REACH is not provided on days of early dismissal.

**There will be a charge of \$10 for each quarter hour, or any portion thereof, for students picked up after 6:00 p.m.** Students who are repeatedly picked up late may be dismissed from the program. Parents are billed monthly for any additional charges.

All participating students must be signed out at the front desk by the parent or one of the authorized persons listed on the student's *REACH Enrollment Information* sheet (see attached). Students may not be released to attend other on-campus activities without written parental permission and arrangements made in advance with REACH staff.

**Students may not attend REACH until the program cost is paid in full or arranged in FACTS.**
